Closed Quotes shall be stapled and placed in sealed envelopes, endorsed “**CQ 3320/08-TRAILER**” and must be placed in the Closed Quote Box at the SCM Unit, No.2 Industria Crescent, KwaDukuza, not later than 12h00 on the **11TH AUGUST 2022** where all quotes will be opened in public. Late, electronic or faxed Quotes will not be accepted.

Bids will be evaluated and adjudicated according to the following criteria:

- 80/20 preference points system will apply in terms of the Preferential Procurement Regulations, 2017 (B-BBEE Status Level Of Contribution – An Original or certified copy of a Sworn Affidavit signed by the EME representative and attested by a Commissioner of Oaths OR A copy of a BBEE Certificate issued by CIPC on behalf of DTI for EMEs)
- Council's Supply Chain Management Policy, CIDB and other Applicable Legislation.
- Service Providers Shall be registered on the National Treasury's Central Supplier Database
- Prices tendered must be firm and inclusive of VAT
- The validity of the Tax Clearance Certificate issued by the South African Revenue Services certifying that the taxes of the bidder are in order will be verified against the information recorded on the Central Supplier Database (CSD).
- Service providers to complete in full all Applicable MBD's.

- **MINIMUM THRESHOLD FOR STEEL PRODUCTS AND COMPONENTS IS 100%.**
