Closed Quotes shall be stapled and placed in sealed envelopes, endorsed “**CQ 3365/10 – SCENE LIGHTS**” and must be placed in the Closed Quote Box at the SCM Unit, No.2 Industria Crescent, KwaDukuza, not later than 12h00 on the **12TH OCTOBER 2022** where all quotes will be opened in public. Late, electronic or faxed Quotes will not be accepted.

Bids will be evaluated and adjudicated according to the following criteria:

- 80/20 preference points system will apply in terms of the Preferential Procurement Regulations, 2017 (B-BBEE Status Level Of Contribution – An Original or certified copy of a Sworn Affidavit signed by the EME representative and attested by a Commissioner of Oaths OR A copy of a BBEE Certificate issued by CIPC on behalf of DTI for EMEs)
- Council's Supply Chain Management Policy, CIDB and other Applicable Legislation.
- Service Providers Shall be registered on the National Treasury's Central Supplier Database
- Prices tendered must be firm and inclusive of VAT
- The validity of the Tax Clearance Certificate issued by the South African Revenue Services certifying that the taxes of the bidder are in order will be verified against the information recorded on the Central Supplier Database (CSD).
- Service providers to complete in full all Applicable MBD's.
- A copy of the most recent municipal account / utility bill in which the business is registered or any of its Directors, District municipality (water) and Local municipality (rates, electricity and other) or if the bidder is a tenant then a letter or certificate from the landlord indicating that the Municipal Services are not in arrears OR a letter from the Ward Councillor or an Affidavit stating that the ward in which the business operates is Exempt from paying Municipal rates and taxes or Municipal Services. **Failure to submit this will lead to your bid being deemed as non-responsive.**
- First preference to be given to service providers who reside within the KwaDukuza Municipal area of jurisdiction. Proof of address by way of Municipal Utility bill for confirmation or service provider must be registered on the voters' roll.
- First preference will be given to an EME which is at least 51% owned by Black Whom are **WOMAN**.
- Compliance with Regulation 27(2) of the Supply Chain Regulations (Where brand names may be specified an equivalent will suffice)
- Service provider to attach Catalogue of Product Quoted with the Bid.
- Failing to Comply with the above-mentioned Criteria will deem your bid as being Non-Response.

All prospective Bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Council does not bind itself to accept the lowest quote or any quote and reserves the right to accept any part or the whole of any quote and preference will be given to Affirmable Business Enterprises. No bids will be considered from persons in the services of any organ of state.
