A COMPULSORY SITE BRIEFING MEETING SHALL BE CONDUCTED ON 18 November @ 08h30AM AT NO.2 INDUSTRIA CRESCENT, STANGER, SCM OFFICE. NO LATE SERVICE PROVIDERS WILL BE ALLOWED TO PARTICIPATE IN THE SITE BRIEFING MEETING. ONLY THOSE SERVICE PROVIDERS WHO PROVIDE A RECEIPT PROVING PRIOR PAYMENT AND A DOCUMENT WILL BE ELIGIBLE TO PARTICIPATE.

Closed Quotes shall be stapled and placed in sealed envelopes, endorsed "CQ 3400-11 – Electrical Repairs various halls" and must be placed in the Closed Quote Box at the SCM Unit, No.2 Industria Crescent, KwaDukuza, not later than 12h00 on the 24 November 2022 where all quotes will be opened in public. Late, electronic or faxed Quotes will not be accepted.

## Bids will be evaluated and adjudicated according to the following criteria:

- 80/20 preference points system will apply in terms of the Preferential Procurement Regulations, 2017 (B-BBEE Status Level Of Contribution – An Original or certified copy of a Sworn Affidavit signed by the EME representative and attested by a Commissioner of Oaths OR A copy of a BBBEE Certificate issued by CIPC on behalf of DTI for EMEs)
- Council's Supply Chain Management Policy, CIDB and other Applicable Legislation.
- Service Providers Shall be registered on the National Treasury's Central Supplier Database
- Prices tendered must be firm and inclusive of VAT
- The validity of the Tax Clearance Certificate issued by the South African Revenue Services certifying that the taxes of the bidder are in order will be verified against the information recorded on the Central Supplier Database (CSD).
- Service providers to complete in full all MBD's.
- A copy of the most recent municipal account / utility bill in which the business is registered. District municipality (water) and Local
  municipality (rates, electricity and other) or if the bidder is a tenant then a letter or certificate from the landlord indicating that the levies
  are not in arrears OR a letter from the Ward Councillor or an Affidavit stating that the ward in which the business operates is Exempt
  from paying Rates, Electricity and Water. Failure to submit this will lead to your bid being deemed as non-responsive
- Compliance with Regulation 27(2) of the Supply Chain Regulations.
- Minimum Threshold for local content- CABLES 90% (MBD 6.2 AND ANNEXURE C COMPULSORY)
- ONLY THOSE SERVICE PROVIDERS WHO ARE REGISTERED WITH A CIDB GRADING OF 1EB OR 2EB WILL BE CONSIDERED FOR AWARD IN TERMS OF SECTION 18(M) OF COUNCIL'S SCM POLICY.
- First preference will be given to an EME or QSE which is at least 51% owned by black people within the jurisdiction of KDM.
- All conditions as stated in the specifications document.

All prospective Bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Council does not bind itself to accept the lowest quote or any quote and reserves the right to accept any part or the whole of any quote. No bids will be considered from persons in the services of any organ of state.
