Late, electronic or faxed Quotes will not be accepted.

## Bids will be evaluated and adjudicated according to the following criteria:

- 80/20 preference points system will apply in terms of the Preferential Procurement Regulations, 2017 (B-BBEE Status Level Of Contribution – An Original or certified copy of a Sworn Affidavit signed by the EME representative and attested by a Commissioner of Oaths OR A copy of a BBBEE Certificate issued by CIPC on behalf of DTI for EMEs)
- Council's Supply Chain Management Policy, CIDB and other Applicable Legislation.
- Service Providers Shall be registered on the National Treasury's Central Supplier Database
- · Prices tendered must be firm and inclusive of VAT
- Price evaluation will be based on engineers estimate (10% below and above costing)
- The validity of the Tax Clearance Certificate issued by the South African Revenue Services certifying that the taxes of the bidder are in order will be verified against the information recorded on the Central Supplier Database (CSD).
- Service providers to complete in full all MBD's.
- Service providers to ensure compliance with MBD 6.2 local content (Applicable)
- Only locally produced goods or locally manufactured goods, meeting the stipulated minimum threshold for local production and content, will be considered (Annexure C must be completed).

- Only those service providers who are registered with CIDB Grading 1 and 2 will be considered for the award
- MBD 6.1, Clause 7 must be completed. Failure to complete will invalidate your bid where brand is specified equivalent will suffice)

Council does not bind itself to accept the lowest quote or any quote and reserves the right to accept any part or the whole of any quote and preference will be given to Affirmable Business Enterprises. No bids will be considered from persons in the services of any organ of state.
