NO LATE SERVICE PROVIDERS WILL BE ALLOWED TO PARTAKE IN THE SITE BRIEFING MEETING. <u>DOCUMENTS TO BE DISPERSED ON SITE</u>. ONLY THOSE SERVICE PROVIDERS WHO PROVIDE A RECEIPT PROVING PRIOR PAYMENT WILL BE GIVEN A CLOSED QUOTE DOCUMENT.

Closed Quotes shall be stapled and placed in sealed envelopes, endorsed "CQ 2608-06 – ELECTRICAL WORK – BALLITO PRO" and must be placed in the Closed Quote Box at the SCM Unit, No.2 Industria Crescent, KwaDukuza, not later than 12h00 on the <u>14 JUNE 2019</u> where all quotes will be opened in public. Late, electronic or faxed Quotes will not be accepted.

Bids will be evaluated and adjudicated according to the following criteria:

- 80/20 preference points system will apply in terms of the Preferential Procurement Regulations, 2017 (B-BBEE Status Level Of Contribution – an original or certified copy of the certificate is required)
- Council's Supply Chain Management Policy
- Service Providers Shall be registered on the National Treasury's Central Supplier Database
- Prices tendered must be firm and inclusive of VAT
- The validity of the Tax Clearance Certificate issued by the South African Revenue Services certifying that the taxes of the bidder are in order will be verified against the information recorded in the Central Supplier Database (CSD).
- Service providers to complete in full all MBD's.
- Service providers to ensure compliance with MBD 6.2 local content
- A copy of the most recent municipal account / utility bill in which the business is registered. District municipality (water) and Local municipality (rates, electricity and other) or if the bidder is a tenant then a letter or certificate from the landlord indicating that the levies are not in arrears OR a letter from the Ward Councillor or an Affidavit stating that the ward in which the business operates is Exempt from paying Rates, Electricity and Water. Failure to submit this will lead to your bid being deemed as non-responsive
- Compliance with Regulation 27(2) of the Supply Chain Regulations.
- First preference to be given to service providers who reside within the KwaDukuza Municipal area of jurisdiction. Proof of such in the name of company to be attached as per bid document requirements.
- Contractors must be registered on the Electrical Contractors database at the Electrical Business Unit.
- Conditions as stated in the specifications document.
