- The validity of the Tax Clearance Certificate issued by the South African Revenue Services certifying that the taxes of the bidder are in order will be verified against the information recorded in the Central Supplier Database (CSD).
- Service providers to complete in full all MBD's. Failure to complete all MBD's will invalidate the Closed Quotation.

- A copy of the most recent municipal account / utility bill in which the business is registered. District municipality (water) and
  Local municipality (rates, electricity and other) or if the bidder is a tenant then a letter or certificate from the landlord
  indicating that the levies are not in arrears OR a letter from the Ward Councillor or an Affidavit stating that the ward in
  which the business operates is Exempt from paying Rates, Electricity and Water. Failure to submit this will lead to your
