CALL FOR THE EXPRESSION OF INTEREST FROM SUPPLIERS AND PROFESSIONAL SERVICE PROVIDERS TO REGISTER ON THE COMMUNITY WORK PROGRAMME (CWP) DATABASE IN WESTERN CAPE (WC) AND KWAZULU NATAL (KZN)

CWP is a government programme, based in the Department of Cooperative Governance (DCoG), with the primary purpose to create an employment safety net. Each site employs an estimated 1 000 participants. The sites are managed by Non-Profit Organisations (NPOs) and as such, Insika Foundation is the NPO responsible for the Western Cape (**City of Cape Town, West Coast and Cape Wine Lands**) and Kwazulu-Natal (**iLembe, Zululand, King Cetshwayo, uMkhanyakude, uMzinyathi, uMgungundlovu, uThukela, and Amajuba Districts as well as eThekweni Metro**) as appointed by DCoG.

Accordingly, Insika Foundation is calling for the expression of interest from the Suppliers and Professional Service Providers to be registered on the Supplier Database as Approved Suppliers for the following Goods, Services and Training amongst others, namely:

1. Personal Protective Equipment (overalls, safety boots, dust masks etc.);
2. General Tools and Materials (wheel barrows, rakes, detergents, first aid kits etc.);
3. Agricultural inputs (seeds, seedlings, pesticides, herbicides, hose pipes etc.);
4. Office Equipment (laptops, printers etc.); and
5. Training Courses (Both accredited and non-accredited service providers) – e.g. Agriculture, Home Based Care, Early Childhood Development, First Aid, Cooking and Catering, Sewing, Plumbing, Painting, House Building and other Training.
