PROVISION OF INDIGENT AND PAUPER BURIAL SERVICES FOR A PERIOD OF THREE (3) YEARS

In terms of Chapter 11 of the Municipal Finance Management Act No 56 of 2003, tenders are hereby invited for the above.

The physical address for collection of tender documents is No. 2 Industria Crescent, Lavoipierre Building, SCM/Stores offices KwaDukuza upon presentation of a receipt proving prior payment of a non-refundable fee of R160.00 (inclusive of VAT), having been made at the Municipal Finance Directorate, General Justice Mpanza Building, 104 Mahatma Gandhi Street, KwaDukuza (Cash only). **Tender documents will be available from 10h00 on 19th December 2022. A **compulsory clarification meeting**, with representatives of the Employer, will take place at the **KwaDukuza Municipality: PMU Boardroom, Lavoipierre Building**, 2 Industria Crescent, KwaDukuza, 4450 on **25 January 2023, starting at 10H00**. This meeting will be followed by an inspection of the site. Failure to attend the compulsory clarification meeting and site visit will disqualify the tender. Doors to the venue will be closed at **10H00** and the briefing will commence immediately. Late attendance will not be accepted and tenderers will **NOT** be admitted into the meeting venue. Only those tenderers who are in possession of a tender document shall be permitted to participate in discussion at the compulsory clarification meeting and site inspection. **All Bidders need to adhere to COVID19 regulations.**

Tenders shall be placed in sealed envelopes, endorsed “**TENDER NO. MN 233/2022 PROVISION OF INDIGENT AND PAUPER BURIAL SERVICES FOR A PERIOD OF THREE (3) YEARS**” and at the Lavoipierre Building (Stores), **NO.2 Industria Crescent Lavoipierre Building SCM / Stores** KwaDukuza, not later than **12h00 on 7 FEBRUARY 2023**, at which time the tenders will be opened in public. Tenders are to be submitted on the tender documentation provided by the Municipality. Late, electronic or faxed tenders will not be accepted.

Tenders will be evaluated and adjudicated according to the following criteria: -

- 80/20 preference points system will apply in terms of the Preferential Procurement Regulation. 2017 (B-BBEE Status Level of Contribution - an original or certified copy of the certificate is required).
- Contractor shall be registered on the National Treasury's Central Supplier Database.
- Council's Supply Chain Management Policy and other applicable legislations.
- Prices tendered must be firm and inclusive of VAT.
- Contractor shall provide the Municipality with a compliance clearance PIN to verify your tax compliance status.
- A copy of the most recent municipal account / utility bill (Not older than 3 months) in which the business is registered, District municipality (water) and Local municipality (rates, electricity and other) or if the bidder is a tenant then a letter or certificate from the landlord indicating that the levies are not in arrears OR a letter from the ward councillor or an Affidavit stating that the ward in which the business operates is exempted from paying rates, electricity and water.
- The tender offer validity period will be 90 consecutive days
- The tenderer must submit with his/her tender offer a **valid certified copy certificate of competency issued by the relevant authority** in terms of the Regulations Relating to Funeral Undertakers' Premises, Government Notice No. R237 of 8 February 1985 framed under Section 33 and 39 of the Health Act 1977 (Act 63/1977).

All prospective tenderers will be screened in accordance with the National Treasury's Defaulters Database.

Council does not bind itself to accept the lowest tender or any tender and reserves the right to accept any part or the whole of any tender and **preference will be given to an EME (exempted micro enterprise) or QSE (qualifying small Enterprise) which is at least 51% owned by black people residing within the KwaDukuza Jurisdiction area.** The Municipality also reserves the right to call on preferred bidders to form a joint venture with a BEE company. Canvassing in any form in the gift is strictly prohibited and will lead to the disqualification of the tender. No bids will be considered from persons in the services of any organ of the state.
