The KwaDukuza Municipality invites tenders for the above. Only Tenderers who are registered with CIDB in a contractor grading of 1 SL or higher will be eligible to tender. Tenderers will have proof of CIDB Registration by closing date failing which the tender will be disqualified. Tenderers shall be registered on National Treasury's Central Supplier Database.

A compulsory clarification meeting, with representatives of the Employer, will take place at the KwaDukuza Municipality: SCM BOARD RM (Stores Building), 2 Industria Crescent on **12 DECEMBER 2019**, starting at 10h00. Failure to attend the compulsory clarification meeting will disqualify the tender. Doors to the venue will be closed at 10H00 and the briefing will commence immediately. Late attendance will not be accepted and contractors will not be admitted into the venue. Only those tenderers who are in physical possession of a tender document shall be permitted to participate in discussion at the compulsory clarification meeting.

Tenders shall be placed in sealed envelopes, endorsed with **TENDER NO. MN 148/2019 MANUFACTURE, SUPPLY AND DELIVERY OF 8/14 CUBIC METER STEEL BULK REFUSE COLLECTION CONTAINERS** and be placed in the Tender Box at the Municipal Offices, **14 Chief Albert Luthuli Street**, KwaDukuza, not later than **12h00 on 23 JANUARY 2020**, at which time the tenders will be opened in public. Tenders are to be submitted on the tender documentation provided by the Municipality. Late, electronic

or faxed tenders will not be accepted.

**Bids will be evaluated and adjudicated according to the following criteria:**

80/20 preference points system will apply in terms of the Preferential Procurement Regulations, 2017 (B-BBEE Status Level of Contribution - certified copy of the certificate is required)

Council's Supply Chain Management Policy, CIDB and other applicable legislations. Contractor shall be registered on the National Treasury's Central Supplier Database. Contractor having a CIDB grading of **1SL** or higher.

Contractor shall provide the Municipality with a compliance clearance PIN to verify your tax compliance status.

Certificate of Attendance at the clarification meeting.

Prices tendered must be firm and inclusive of VAT.

NB: Bidders who are listed in the National Treasury register of defaulters and restricted suppliers will be automatically disqualified.

A copy of Municipal Utility Bill (not older than 3 months) in which the business is registered. District municipality (water) and Local municipality (rates, electricity and other) or if the bidder is a tenant then a letter or certificate from the landlord indicating that the levies are not in arrears. Should the above not be applicable, the service provider shall submit an affidavit.

**Service providers to ensure compliance with MBD 6.2 – Local content (applicable)  
Minimum threshold for local content is 100% for structural steel.**

All prospective tenderers will be screened in accordance with the National Treasury's Defaulters Data Base. Council does not bind itself to accept the lowest tender or any tender and reserves the right to accept any part or the whole of any tender and preference will be given to Affirmable Business Enterprises within KwaDukuza jurisdiction area. The Municipality also reserves the right to call on preferred bidders to form a joint venture with a BEE company. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the tender. No bids will be considered from persons in the services of any organ of state.
