A compulsory clarification meeting, with representatives of the Employer, will take place at the KwaDukuza Municipality: 2 Industria Crescent, Lavoipierre Buidling, PMU Board Room KwaDukuza, 4450 on the **23 JUNE 2022**, starting at **10H00**. This meeting will be followed by an inspection of the site. Failure to attend the compulsory clarification meeting and site visit will disqualify the tender. Doors to the venue will be closed at **10H00** and the briefing will commence immediately. Late attendance will not be accepted and tenderers will **NOT** be admitted into the meeting venue. Only those tenderers who are in possession of a tender document shall be permitted to participate in discussion at the compulsory clarification meeting and site inspection. **All Bidders need to adhere to COVID19 regulations.**

Participants are required to state the tender number and company name on the subject heading. Responses will be directed to all participants via email, and will be made available on the KDM website. Only those tenderers who are in possession of a tender document shall be permitted to participate in discussion

Tenders shall be placed in sealed envelopes, endorsed with **TENDER NO. MN32/2022 KWADUKUZA MUNICIPALITY DATA CLEANSING .This is a Two stage tender, envelope 1(Technical proposal) envelope 2 (Financial offer)** be placed in the Tender Box at the SCM Municipal Offices, No. 2 Industria Crescent, KwaDukuza, Lavoipierre Building, SCM Offices not later than

12h00 on 18TH JULY 2022, at which time the tenders will be opened in public. Tenders are to be submitted on the tender documentation provided by the Municipality. Late, electronic, or faxed tenders will not be accepted.

Tenders will be evaluated and adjudicated according to the following criteria: -

- 80/20 preference points system will apply in terms of the Preferential Procurement Regulation. 2017 (B-BBEE Status Level of Contribution - an original or certified copy of the certificate is required).
- Contractor shall be registered on the National Treasury's Central Supplier Database.
- Council's Supply Chain Management Policy and other applicable legislations.
- Prices tendered must be firm and inclusive of VAT.
- Contractor shall provide the Municipality with a compliance clearance PIN to verify your tax compliance status.
- A copy of the most recent municipal account / utility bill (Not older than 3 months) in which the business is registered, District municipality (water) and Local municipality (rates, electricity and other) or if the bidder is a tenant then a letter or certificate from the landlord indicating that the levies are not in arrears OR a letter from the ward councillor or an Affidavit stating that the ward in which the business operates is exempted from paying rates, electricity and water.
- The tender offer validity period will be 90 consecutive days
- Only those bidders who have scored the minimum points of 75 will be considered for the second stage evaluation.
- The valuer contracted to the KwaDukuza Municipality to perform specific or other duties linked to the general valuation roll of KwaDukuza Municipality is not permitted to form part of the team required to perform the services specified in this Request for Proposals.

All prospective tenderers will be screened in accordance with the National Treasury's Defaulters Database.

Council does not bind itself to accept the lowest tender or any tender and reserves the right to accept any part or the whole of any tender.

Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the tender. No bids will be considered from the persons in the service of any organ state.
